The purpose of this grant is to help groups within our District obtain conservation grade trees, shrubs, and perennial plants at a minimal cost. These trees, shrubs and perennial plants will be taken from the overflow plants from our yearly seedling tree sale, you may accept or pass on available items.

Small Grant Guidelines:

- 1. Project will take place within West Greeley Conservation District Boundaries
- 2. Group or individual(s) applying for plants are housed within West Greeley Conservation District boundaries.
- 3. Please provide a written plan and a rough sketch to show where/how plants will be used. Please include spacing and approximately the number of required plants, broken out into: Trees, Shrubs and Perennial plants. We will work to fulfill your grant request upon number of trees, shrubs, and perennials. Nothing is species specific, as there are no guarantees for the species you will get. This Grant request is used to ensure overflow plants have somewhere to be planted and cared for.
- 4. Please note, you may request specific species, but there is no guarantee on the specific species you will awarded as these plants are overflow from the Conservation Tree Sale.
- 5. You will be awarded plants in the order of your application- first come, first serve. There are no promises for any plants, this application ensures that you are on our waiting list for these extra plants.
- 6. Plants will be available for pickup by appointment only. There are no guarantees for plant survivability. You are responsible for ensuring that your plants are accurate and viable upon scheduled pickup. You will be responsible for the care and condition of the plants once they are in your possession, this includes but isn't limited to, protection from frost, sunscald, wind damage or other environmental factors.
